#### Feedback Analysis Report

The results were discussed and presented in the College Council meeting dated 17/12/2018 and IQAC meeting dated 10/12/2018.

As College has limited role in syllabus setting or revision, faculty tries to disseminate curriculum in most effective manner and suggestions are reported informally to Board of Studies.

### Consolidated Report of College Council and IQAC

- Faculty were asked to discuss with the members of Board of studies and make an effort to relate the course content with the current scenario in a possible manner.
- It was requested to deliver the course content with practical examples and with reference to real life situations and to encourage the maximum participation of students in the class. Case studies may also be encouraged for practicability.
- Faculty need to develop e-resources and guide the students to access, participate and learn through platforms like Swayam, e-PG Pathshala. Effective use of ICT should be done, e- Content development by students is to be encouraged.
- Link curriculum with issues of gender, environment, sustainability, ICT, nationalism etc
  through talks, debates, discussions, exhibitions, seminars and so on. Social science
  disciplines may stress on surveys related to development of the society.
- As syllabus demands dissertation is in the final semester UG and PG only, there is scope
  only for projects and dissertation during that period. However faculty is to motivate
  students to undertake projects, internship in the first and second year in the case of UG
  and first year in the case of PG.
- Student Exchange is not within the purview of University syllabus, but students can be taken to various institutions of repute and attend classes.
